

Legal Center: Success Story

A Somali tenant came to Isuroon Legal Center for help with their eviction case. He was being evicted for nonpayment of rent and breach of lease. The landlord claimed the tenant allowed a stranger into the property that caused damage to the on-site gym equipment. This was not true. The tenant tried calling multiple legal aid organizations for representation but they denied him. On the day of his trial, he still did not have an attorney so the court graciously granted another continuance. This is when he came to Isuroon Legal Center. We helped him successfully find a volunteer attorney for representation. His eviction case was settled and was expunged from his record!
